

#### Boosting Public Discourse: Evidence-Based Strategies for Reframing Child & Adolescent Immunization

To rebuild widespread confidence in the power of immunizations, advocacy from pediatricians is vital. Making sure that our advocacy is effectively framed can help or hinder progress toward the ultimate goal of ensuring the health of children and adolescents through vaccination.

That's why the American Academy of Pediatrics partnered with the FrameWorks Institute to conduct rigorous social science research to understand attitudes toward vaccine policy and identify framing strategies that can build public support for science-backed approaches. This research has uncovered <u>fresh insights into effective framing</u>, designed especially for pediatricians and other family health practitioners.

The West Virginia Chapter of the AAP is delighted to virtually host the FrameWorks Institute to share more about these new evidence-based communications recommendations with our members. Whether we are sharing information about vaccines in social media or in a news interview, talking with policymakers or addressing a group of parents, these framing strategies can help improve how we talk about vaccines.

**Dr. Julie Sweetland (PhD)** is a sociolinguist and a senior advisor at the FrameWorks Institute, a nonprofit that equips change-makers to lead productive public conversations on scientific and social issues.

Since joining FrameWorks in 2012, Dr. Sweetland has led strategic reframing initiatives on issues like health equity, education equity, and childhood adversity. Her skill in translating framing research into communication strategy helps advocates, policymakers, and researchers drive social change. Since 2017, Julie has played a key role in the Tobacco Disparities Framing Project, which has informed national, state, and local efforts to advance equity-focused approaches to commercial tobacco control.

## Unwinding the Unwinding: Medicaid Redetermination's Impact on Child Health and How Pediatricians Can Help

For the large majority, maybe even all pediatricians, we have cared for a child who was covered by Medicaid. Medicaid is a lifeline program for more than 34 million children who rely on it, including those with special health care needs. Medicaid has always been a children's program and is even more important for children today. Right now, however, children and families are at risk of losing or have lost their coverage as states review their programs and check who is still eligible. The Medicaid eligibility redetermination process is also referred to the "unwinding." More than 1 in 5 Americans rely on Medicaid for their health insurance, including children, parents, seniors, pregnant people, people with disabilities, and low-income adults. During the public health emergency, Medicaid/Children's Health Insurance Program (CHIP) enrollment grew substantially – more than 7 million more children enrolled in Medicaid and CHIP during the pandemic.

A policy was put in place during the COVID pandemic to make sure no one lost their Medicaid coverage during the public health emergency. That policy ended in April 2023 and now states are in the process of reviewing their programs to check who is still eligible. At least 13.3 million enrollees have been disenrolled as of December 20, 2023, and 71% of all people disenrolled had their coverage terminated for procedural reasons, such as paperwork problems like returned mail. Any gaps in health care coverage can be detrimental. We know that when someone is uninsured, they are more likely to delay or go without the care they need. That means that kids might be unable to get follow-up care for injuries and newly diagnosed chronic conditions, or they might skip doses of their medication.

As pediatricians, we must do everything we can to ensure people do not lose health care coverage. And, if a person is no longer eligible for Medicaid, they must be seamlessly transitioned to another source of coverage. There is too much at stake for children and we can't afford to lose the gains we've made to keep kids insured.

Pediatricians are natural advocates who play a powerful role in creating lasting and meaningful change for the public and the patients we serve. I know first-hand the importance of Medicaid to my patients and what's at stake if they were to lose this vital coverage. Right now, we're at a critical crossroads and children and families need our help for them to stay covered.


